#### **BIOGRAPHICAL**

Henry Nielson Brush was born March 12, 1810 in New York City. He was educated at Columbia College, moving to the town of Moira, Franklin County, New York where he owned two large farms, a stone grist-mill and a sawmill. He was the founder of Brush Mills which todaycalled Brushton. He married Juanilla Marie de Jouve of Cuba in 1831. Henry was an active member of the Whig party and was postmaster for several years. Brush died November 2, 1872 in Brushton.

### SCOPE AND CONTENT

This collection contains correspondence, deeds, land contracts, financial records and wills. The collection came to the archives in notebooks and organized by year. Each notebook also had a listing and sometimes a brief description of the letters inside. These have been kept and put in the folder with the letters. Each document has been given a number (in red pencil) by a previous owner of the collection. There are occasional gaps in the numbering, which are indicated by item numbers in parentheses and "np" for "not present". The collection has been put in acid-free folders and acid-free boxes.

#### **PROVENANCE**

St. Lawrence University acquired this collection between the years 1959-1963 from Susan Andrews Brush, and Neilson C. Brush, of Malone, NY and Orlando, FL. Mr. Brush was the grandson of Henry Neilson Brush.
