The New york and Ontario Power Comapny Papers center around the attempt to harness the St. Lawrence River for the purpose of producing power. The attempt was made around 1918 when the company applied to the International Joint Commission for approval for "...the obstruction of the waters of the St. Lawrence River at Waddinton, N.Y."

The bulk of the collection concerns the attempt of one William S. Connolly to gain control of land in the area in his belief that because this was the narrowest part of the river it was the logical spot for a power dam. For some reason this never happened. When the dams were built they were built six miles up river and twenty six miles down river.

The collection contains plans, maps, charts, reports, studies and correspondence all related to the New York and Ontario Power Company's attempt to build a dam at Waddington.
