Stop the Olympic Prison (S.T.O.P.)

Historical Note

The Adirondack village of Lake Placid hosted the third winter Olympic Games in 1932. In 1974, the International Olympic Committee awarded the 13th Winter Games to Lake Placid. The Games would be held over 12 days in February of 1980. The federal government, through the United States Olympic Committee, agreed to provide 22 million dollars for construction of housing for the 1,800 athletes, provided a suitable use was found for the "Olympic Village" after the games were concluded. The U.S. Office of Management and Budget, Bureau of Prisons and the Congress agreed to a plan to build a 500 bed medium security prison in nearby Ray Brook for young offenders, age 18-25 and use it as athletes' housing during the Olympic Games.

Scope and Content

This collection documents the widespread effort over a two year period (1978-1979) to raise public awareness of and build opposition to the post-Olympic use of the athletes' housing as a federal prison. It consists primarily of photocopies of hundreds of newspaper and magazine stories, newsletters, editorials and other material documenting the opposition to the prison effort. Also included is internal and external correspondence among and between North Country clergy active in Stop The Olympic Prison (STOP), the New York Moratorium on Prison Construction, and state and federal politicians, as well as posters, brochures and fliers, and a transcript of a civil lawsuit filed by the USOC against STOP. The collection is organized chronologically by type of material.
