## 765 kV Line Protest Collection MSS Coll. # 130 10.25 Linear Feet

## <u>History</u>

The North Country Defense Committee and the coalition Upstate People for Safe Energy Technology (UPSET) were the most prominent groups that opposed the implementation of the **765 kV line** by the New York State Power Authority. For a five-year period, between 1975 and 1980, these two groups and some 20 others fought the construction of a 150 mile 765 kV Power line in Northern New York State. The **North Country Defense Committee** (NCDC) was adamantly opposed to any power developments that would cause any unsafe conditions. In addition to the power line controversy, a priority of the NCDC was to inform the public of the possibility of the construction of a nuclear power plant in Upstate New York. **Upstate People for Safe Energy Technology** (UPSET) was established as a not-for-profit corporation under New York State Law in May 1976. UPSET, Inc. existed to gather and disseminate information to further understand the issues relating to safe energy technologies, and to insure that planned and existing energy technologies are safe ones. UPSET defined safe energy technologies as those that do not pose serious danger to life or to the planet while working for energy systems that are safe, pollution free, and accessible to all the people at a reasonable cost.

## Scope and Content

Included in this collection are instructions how properly to protest through the use of a coalition, questionnaires given to local people affected by the line, scientific evidence of the effects of electromagnetic pollution on people, animals, and land, photographs, and legal papers pertaining to the issue. Also includes scrapbooks and maps/blueprints from Walter Reimer, President of UPSET.
