Biographical

S.L. Clark and Son was a barrel manufacturing and lumber mill business located in Parishville, New York from approximately 1870 until 1908. The primary item manufactured at the mill was butter tubs. According to Curtis's *Our County and Its People* (1894), the factory employed as many as 125 men in summer and built up to 350,000 butter tubs a year in 1894. S. L. Clark was born in Hermon, NY in 1844. After service in the Civil War, he married Mary Keeler and had four children. He relocated to Parishville and was engaged in several businesses before acquiring the lumber company.

Scope and Content

The collection consists hundreds of letters, invoices, memos and other correspondence between various suppliers and S.L. Clark & Son between 1896 and 1900. The correspondence is remarkable in that it is written on sometimes very elaborate company letterheads used by businesses at the turn of the 20th century. Much of the correspondence is typed but some is hand-written.

Provenance

The collection was purchased in two lots. The first was bought in January 2014 from Ted Comstock. The remainder of the collection was purchased from Tom Jenison in August of 2018

Organization and arrangement

Overall organization is chronological by year. Within each box, folders are arranged alphabetically by the name of business. Within each folder, correspondence is arranged chronologically.
